My participation in this activity may result in injury or illness, including, but not limited to, disability or death. These risks and dangers may be caused by the negligence of the participants, the negligence of the owners, employees, officers or agents of Trophies Only LLC, breaches of contract, the forces of nature, or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes and such other risks, hazards and dangers that are integral to recreational activities that take place on a frozen body of water.

In consideration of my participation in ice fishing and or recreational rides in a SHERP OHV with Trophies Only LLC, I agree that by my participation in this activity, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers or employees of Trophies Only LLC, or any other person including myself. I also verify that I am in good health, not under the influence of any drugs or alcohol of any kind, and I am capable of participating in ice fishing and or recreational rides in a SHERP OHV. I have read and understand all rules involved with ice fishing with Trophies Only LLC. My participation in all activities with Trophies Only LLC is voluntary. Representatives of Trophies Only LLC, have taken reasonable steps to provide me with appropriate information so that I acknowledge ice fishing is not without risk. Certain risks are inherent of ice fishing and or recreational rides in a SHERP OHV and cannot be eliminated without destroying the unique character of the activity and can be the cause of loss or damage, the risk of which I assume.

I, on behalf of myself, my personal representatives and heirs hereby voluntarily agree to release, discharge, hold harmless, defend and indemnify Trophies Only LLC and it's owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, or otherwise which may arise out of my participation while ice fishing and or recreational rides in a SHERP OHV. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have at the present time or in the future for the negligent acts or other conduct of the owners, agents, officers or employees of Trophies Only LLC.
